Customized Service and Advocacy - Serving the individual needs and advocating on behalf of the 600 clients and their families that we serve annually. Women of the World's Case Managers support the housing, immigration, social security, and parental rights of their clients. This year alone we saved our ladies over \$86,000 mostly in hospital bills, insurance claims, and housing.
