PARTNERS AHA WOULD OWN A 51% INTEREST IN EACH OF THE GENERAL PARTNER ENTITIES WHILE MDR WOULD OWN THE REMAINING 49% MDR AGREED TO PROVIDE CAPITAL, DEVELOPMENT SERVICES, PROPERTY MANAGEMENT, AND OTHER ASSISTANCE TO AHA FOR THESE PROJECTS BASED ON THESE EXPECTED CONTRIBUTIONS BY MDR, MDR WOULD RECEIVE AN 83 34% INTEREST IN THE "AGGREGATE VALUE" OF CERTAIN FINANCIAL INTERESTS IN THE PROJECT PARTNERSHIPS AND PROPERTIES AND AHA WOULD RECEIVE 16 66% INTEREST IN THIS AGGREGATE VALUE THE AGGREGATE VALUE IS "REPRESENTED BY THE SELLER NOTES, DEVELOPER FEES, CASH FLOW FROM OPERATIONS, DISTRIBUTIONS FROM CAPITAL TRANSACTIONS, AND RESIDUAL VALUE FROM THE PROPERTIES " (SECTION 2(B) OF THE MOU) HOWEVER, MDR DID NOT FULFILL ITS OBLIGATIONS UNDER THE MOU FOR THE REASONS EXPLAINED BELOW, AHA NEVERTHELESS HAS BEEN COMPELLED TO MAKE PAYMENTS TO MDR THAT CONSTITUTE EXCESS BENEFIT TRANSACTIONS RELATED TO THESE AFFORDABLE HOUSING PROJECTS (THE "PROJECTS") EXCESS BENEFIT TRANSACTIONS MDR WAS EXPECTED TO ADVANCE ALL OF THE CAPITAL NEEDED AND DO ALMOST ALL OF THE DEVELOPMENT WORK TO OBTAIN CONTROL OF THE AFFORDABLE HOUSING PROPERTIES AND TO GET THEM REFINANCED AND REHABILITATED HOWEVER, MDR DID NOT PROVIDE THE EXPECTED CAPITAL OR DEVELOPMENT WORK FOR THESE PROJECTS DURING THE REFINANCE AND REHABILITATION OF THE PROJECTS, MDR ARRANGED TO HAVE THE TAX CREDIT SYNDICATOR PAY ALL DEVELOPER FEES DIRECTLY TO ENTITIES THAT MDR CONTROLS AHA PROVIDED ALL OF THE CAPITAL AND DID ALMOST ALL OF THE DEVELOPMENT WORK TO GET CONTROL OF THE AFFORDABLE HOUSING PROPERTIES THAT WERE SOLD TO THE PROJECT PARTNERSHIPS BECAUSE AHA OWNED THESE PROPERTIES WHEN THEY WERE SOLD TO THE PROJECT PARTNERSHIPS AT APPRAISED VALUE, AHA ALONE OWNS \$23 MILLION OF SELLER NOTES FROM THE SALE OF THE PROPERTIES TO THE PROJECT PARTNERSHIPS MDR HAS RECEIVED EXCESS BENEFIT PAYMENTS IN TWO PRIMARY WAYS 1 DEVELOPER FEES FIRST, DURING THE REFINANCE AND REHABILITATION OF THE PROJECTS, MDR ARRANGED TO HAVE THE TAX CREDIT SYNDICATOR PAY ALL DEVELOPER FEES DIRECTLY TO ENTITIES THAT MDR CONTROLS THROUGH THAT ARRANGEMENT, MDR WAS PAID \$5,815,164 OF DEVELOPER FEES IN 2018 AND PRIOR YEARS EVEN THOUGH AHA DID APPROXIMATELY 50% OF THE DEVELOPMENT WORK AS A RESULT, MDR RECEIVED \$2,909,641 OF EXCESS BENEFIT PAYMENTS FROM DEVELOPER FEES 2 INTEREST ON SELLER NOTES SECOND, AHA HAS BEEN FORCED TO PAY MDR INTEREST ON SELLER NOTES OWNED BY AHA, EVEN THOUGH MDR DID NOT PROVIDE THE CAPITAL OR DEVELOPMENT SERVICES TO JUSTIFY THIS PAYMENT IN AUGUST 2017, MDR INITIALLY DEMANDED A \$200,000 PAYMENT FROM AHA TO ACHIEVE THE FINANCIAL INTEREST PERCENTAGES OUTLINED IN THE MOU BECAUSE MDR HAD NOT MADE SUFFICIENT CONTRIBUTIONS TO THE PROJECTS TO JUSTIFY THIS PAYMENT, AHA REFUSED TO MAKE THE PAYMENT ON THE ADVICE OF ITS LEGAL COUNSEL DUE TO CONCERNS ABOUT POTENTIAL PRIVATE INUREMENT AND PRIVATE BENEFIT, AND AHA'S BELIEF THAT THIS PAYMENT WOULD CONSTITUTE AN EXCESS BENEFIT TRANSACTION UNDER INTERNAL REVENUE CODE SECTION 4958 THROUGH MDR'S MAJORITY VOTE ON THE BOARD OF GOVERNORS OF BOTH GENERAL PARTNER ENTITIES, MDR RESPONDED TO AHA'S REFUSAL TO PAY BY UNILATERALLY REMOVING AHA'S REPRESENTATIVE FROM HIS ROLE AS THE PRESIDENT AND CHIEF MANAGER OF THE GENERAL PARTNER ENTITIES AND REPLACING HIM WITH AN MDR REPRESENTATIVE, AND ALSO DELAYED DISTRIBUTION OF \$990,285 OF SURPLUS CASH FROM THE PROJECT PARTNERSHIPS TO AHA UNTIL MDR RECEIVED THE PAYMENTS IT DEMANDED FROM AHA AHA ATTEMPTED TO FIND A SOLUTION THAT COMPLIED WITH THE FEDERAL TAX LAW GOVERNING EXCESS BENEFIT TRANSACTIONS, HOWEVER, MDR REFUSED TO NEGOTIATE AND ULTIMATELY FILED A LAWSUIT IN SEPTEMBER 2018 BEFORE HEARING AHA'S EXPLANATION OF THE EXCESS BENEFIT TRANSACTION ISSUES, A JUDGE RULED IN A PRELIMINARY HEARING THAT AHA MUST PAY MDR ACCORDING TO THE MOU, INCLUDING PAYMENT OF THE 83 34% OF INTEREST ON SELLER NOTES OWNED BY AHA BECAUSE THE LITIGATION DID NOT PROGRESS PAST THIS PRELIMINARY HEARING, THE COURT NEVER ADDRESSED THE TAX ISSUES OR CONSIDERED AHA'S CONCERNS REGARDING EXCESS BENEFIT TRANSACTIONS ON THE ADVICE OF AHA'S LEGAL COUNSEL, AHA SUBSEQUENTLY ENTERED INTO A BINDING MEDIATION PROCESS WITH MDR THE PARTIES AGREED TO A MEDIATION SETTLEMENT AGREEMENT (THE "SETTLEMENT AGREEMENT") THAT REQUIRES AHA TO PAY MDR ACCORDING TO THE 83 34% FINANCIAL INTEREST PERCENTAGE OUTLINED IN THE MOU IN ORDER TO RESOLVE THE LAWSUIT, ALTHOUGH IT REMAINS AHA'S POSITION THAT MDR HAS NOT PROVIDED THE CAPITAL OR DEVELOPMENT SERVICES TO JUSTIFY THIS PAYMENT, AS EXPLAINED ABOVE SPECIFICALLY, THE SETTLEMENT AGREEMENT REQUIRED AHA TO PAY \$1,016,639 TO MDR IN JULY OF 2019 FROM INTEREST ON THE SELLER NOTES OWNED BY AHA ADDITIONALLY, AS A RESULT OF THE SETTLEMENT AGREEMENT, MDR HAS ALSO RECEIVED BETWEEN OCTOBER 2019 AND APRIL 2020 AN ADDITIONAL \$620,992 OF PAYMENTS OF SURPLUS CASH FROM THE PROJECT PARTNERSHIPS THAT WOULD HAVE OTHERWISE BEEN PAID TO AHA FROM INTEREST ON THE SELLER NOTES OWNED BY AHA IN CONCLUSION, MDR HAS RECEIVED EXCESS BENEFIT PAYMENTS OF (1) \$2,909,641 FROM DEVELOPER FEES DURING 2018 AND PRIOR YEARS (AS REPORTED ON AHA'S 2018 FORM 990) AND 2) ADDITIONAL PAYMENTS DURING 2019 AS OF THE DATE OF THIS FILING OF \$1,636,631 FROM INTEREST ON SELLER NOTES OWNED BY AHA (WHICH WILL BE REPORTED ON AHA'S 2019 FORM 990) FOR TOTAL EXCESS BENEFIT PAYMENTS TO DATE OF \$4,547,272 ACCORDINGLY, BECAUSE THESE PAYMENTS EXCEED THE VALUE OF CAPITAL AND DEVELOPMENT SERVICES PROVIDED BY MDR, AHA MUST REPORT THESE PAYMENTS AS EXCESS BENEFIT TRANSACTIONS
