Through grant making and partnership development, Youthprise works to transform how funders, institutions, providers and communities work with youth We distribute, leverage and coordinate funds to build more effective expanded learning systems and promote innovation in youth engagement In 2015, we brought more than \$3 million in new federal funding to Minnesota and were one of 8 organizations nationally to receive a social innovation fund grant from the Corporation for National and Community Service We formed numerous leveraging partnerships where Youthprise catalyzed new investments of more than \$2 million for youth programming

Through systems building, Youthprise's goal is to develop coordinated, sustainable citywide and statewide systems that provide access to high quality expanded learning programs for underserved and under-engaged youth In 2015, we made strategic investments of \$4.4 million to 41 youth-serving organizations, 5 citywide networks and 1 statewide afterschool network to build their capacity to improve organizational effectiveness, collect and report data, improve program quality and model authentic youth engagement More than 26,000 youth are served through these initiatives Results include increased use of the youth program quality assessment (32 organizations) and engaging 27 organizations in using the charities review council protocols for effective nonprofit organizations In 2015, we also launched the nutrition program, with Youthprise serving as a hub to deliver more than 67,000 healthy meals and snacks to 1200 youth in 14 after school and summer learning programs

Through innovation in youth engagement, Youthprise works to authentically engage youth in the design and implementation of programs, policy, systems, philanthropy, and research and evaluation Grants support innovative strategies developed by and delivered to young people and creative approaches that value youth/adult partnerships and authentic youth engagement In 2015, we launched 8 youth bank sites, the first in the U.S., an innovative youth philanthropy initiative where groups of youth research community issues and distribute grants to community-based organizations to address them We also initiated the youth participatory action research network with six organizations who are engaging groups of youth is conducting research and developed action plans to tackle community issues
