CYO helps saves lives and develop youth On the frontlines to prevent violence and support disadvantaged people to thrive, CYO provides outreach, mentoring, case management, and support to high risk youth and young adults in the Bay Area At CYO, we believe that once you establish a trusting and caring relationship, even with the very highest risk youth and young adults, you can support them to overcome challenges and provide them with the opportunities to succeed Each year, CYO works with hundreds of high-risk youth and young adults throughout the Bay Area to support them in refraining from violence, graduating from high school, and becoming productive and successful adults. More than half of our team of 23 staff are individuals who have experienced incarceration and have transformed their lives and now provide examples and leadership to youth and young adults striving to do the same We are proud of the tremendous growth and success we have experienced In Fiscal-Year 2017-2018, CYO was able to support 411 youth and young adults who were in the criminal justice system and at the very highest risk to engage in violence Our staff were able to help them remain free from violence and incarceration and become contributing members of our community. The first step in CYOs work to help transform the lives of criminal justice system-involved youth and young adults is to establish a Trusting Relationship between our staff and our clients The work of our Case Managers/Outreach Workers/Life Coaches is first and foremost to establish a close and trusting relationship and rapport with each client. Once a strong relationship is developed and the client has had exposure to information and experiences that start their mentality shift, then there can be a greater emphasis on connection to Services, Supports, and Opportunities The CYO Case Manager/Life Coach sit down with each client and ideally also with their family, to develop a detailed Case Plan or Life Plan The plan should identify the clients greatest needs, challenges, as well as strengths This plan should emphasize education, employment and housing as well as overcoming barriers to being successful in those areas The Life Coach and client should agree on a goal in each area (i.e. earn GED, gain full time employment) and identify a service or opportunity to achieve the goal (i.e. local GED program, employment training program) Goals should also include the client collecting all their necessary documentation (birth certificate, State ID or driver license, etc.) Life Coaches do not simply refer their clients to a particular service or program, but personally connect them with the service, program or organization that the Life Coach knows and trusts. The Life Coach should initially transport and personally connect the client to each service provider decisions, which determines their outcomes A critical part of CYOs work is to change the mentality that gives rise to destructive behavior. CYO achieves this by using our staff, who have formed trusting relationships with our clients to be Credible Messengers as an example of people who have changed their lives as well as provide good information and influence. Furthermore, CYO trains its formerly incarcerated staff to deliver a trauma-informed, culturally relevant Cognitive Behavioral Therapy (CBT) curriculum during group sessions with clients The one-on-one work CYOs Life Coaches conducts with clients in addition to the group CBT sessions, creates a Transformative Mentoring approach. Intensive Young Adult Case Management CYO provides intensive case management/life coaching to young adults in Oakland who have been identified as individuals who are the most highly at risk of being involved in violence. CYO case managers, referred to as Life Coaches, engage their clients in trusting relationships and support them in remaining alive, free from incarceration, and becoming successful Individuals identified through CYOs Street Outreach program or Oakland's Ceasefire strategy are assigned to one of CYOs professional Life Coaches Life Coaches develop detailed Life Plans with each of their clients, which includes goals for remaining safe and achieving successful outcomes in education, employment, housing, and if needed, mental health and drug treatment services Although the initial focus is for Life Coaches to establish strong relationships with their clients, when the client is ready, Life Coaches connect them to services, supports and opportunities that help them achieve the goals of their Life Plan. In FY 17-18, the Intensive Young Adult Case Management program served 105 young people. The average client age was 24. Life Coaches have been very successful at keeping their clients safe and with the help of our partnering agencies, nearly all clients seeking employment have been able to secure a job. In FY 17-18, of the 105 clients served by CYOs Young Adult Intensive Case Management program, 15 were rearrested, and the charges were dropped for six of those clients. For the other 9, only 4 were convicted of a crime and two others received probation violations constituting a less than 9% recidivism rate. There are three cases still pending. Even though all 105 clients were identified by the Oakland Police Department or otherwise met the criteria for being of very high risk to be involved in gun violence, none of the clients were arrested for a shooting and none were victims of gun violence. Street Outreach. CYO leads the City of Oakland's violence interruption strategy, Street Outreach, in the East and Central sections of the City. Our skilled and trained Street Outreach Workers canvass the neighborhoods hardest hit by crime and violence and outreach to high risk individuals and provide counsel, support, and connection to needed services. Street Outreach Workers interrupt impending acts of violence on the street, mediate brewing conflicts, and provide hope and direction to those most in need. CYO employs two teams of Street Outreach staff. Each team consists of an Area Team Leader as a supervisor and three Street Outreach Workers. In addition to canvassing neighborhoods with high rates of violence, Outreach Workers also provide limited case management services to high risk individuals. To build neighborhood cohesion and establish relationships in the community, the Street Outreach teams also regularly host neighborhood events and present at community meetings. As members of Oakland's emergency response network, the Street Outreach teams are called out to shooting and homicide scenes. Street Outreach Workers support families of the victims and engage the friends and social networks of the victim to discourage retaliation and offer any needed services. The Street Outreach program is a partnership with the community-based organization Youth Alive in Oakland which receives funding from Oakland Unite and subcontracts with CYO. In FY 17-18, the Street Outreach Workers provided short-term case management services to 201 people. The average client age was 26 years old. Youth intensive life coaching. In partnership with the Oakland Unified School District (OUSD), Alameda County, and Oakland Unite, CYO provides intensive case management services to youth being released from the Alameda County Juvenile Hall (detention center). CYO case managers/Life Coaches help youth enroll and remain in school. Youth being discharged from the detention center going home to Oakland are assigned a Life Coach from CYO, are enrolled in school prior to their release, are given health plans from the county's Health Care Services Agency, and most are also placed on probation. CYO youth Life Coaches are assigned to different schools within OUSD and work with the youth recently released from custody at their schools, in their homes, and in the community. CYO Life Coaches establish trusting relationships with the youth on their case load, help them remain and excel in school, support them in staying safe, and connect them to needed services and supports. In FY 17-18, the Intensive Youth Case Management program served 75 young people. The average client age was 16. Temporary Relocation. For individuals facing the imminent threat of gun violence, CYO offers emergency temporary relocation. The innovative new program is a partnership with CYO and organizations that are a part of Oakland's Emergency Response Network. The main purpose is to remove people from imminent danger to quell tensions and mediate conflicts. CYOs Relocation Specialists work with individuals and their families, as well as partner agencies, to either provide temporary housing out of the area or support permanent relocation with family or friends in another region. This life saving, intensive program is a pilot strategy that has proven effective and CYO is working to increase its funding and capacity to serve more clients and save more lives. Funding for the Emergency Relocation program comes from Oakland Unite. Since the creation of the program in 2016,
