In December 2019, AWTN Board of Directors voted to shift the financial reporting period from July 1 to June 30 to a calendar year and to file a Short Year 990 for July 1 – Dec 31, 2019, for the 2019 990 filing. A large portion of the 2019 income for AWTN was recorded in the previous 990 filing for 2018, for fiscal year end June 30, 2019 and is not included in this 2019 990 filing.

As a result, the 990 filing shows a significant decrease in revenues and corresponding loss recorded for the current fiscal period.

This decrease is due to the timing of the grants received based on the filing, not on a decrease in the actual income of AWTN.
