Several circumstances contributed to the organization missing this deadline. First, the organization's officers are part-time volunteers, receiving no compensation for their service. The Executive Director is a physician who oversees the operation of the main medical clinic, and additional locations, which provide free or substantially discounted medical and dental services to underserved, impoverished and often homeless people in the community. Further, the organization employs nearly forty employees as well as approximately seventy volunteers whose activities must ultimately be overseen by the Executive Director or another physician employee. Due to these challenges, the organization has engaged an advisor well-versed in not-for profit account and taxation to assist with the organization's reporting and tax filings. The advisor's office had just gone through the implementation of a new due date management system to monitor due dates for its clients. During the transition to this new system, the advisor inadvertently failed to file an extension by February 15, 2018, the due date for the 2016 Form 990. The advisor's failure to file the extension was discovered by the advisor shortly after the due date. At that point, an extension was filed, albeit late, to indicate that the organization intended to extend the return until information could be gathered to prepare a complete and accurate return. Further, the return is now being filed, nearly five months prior to the extended due date, indicating the organizations commitment to filing their return timely. In addition to the reasonable cause detailed above, we respectfully request that no penalty be assessed, as a penalty would only serve to further challenge the important humanitarian mission of this organization, supported mainly by the generous
