A SECOND MISSION IS OUR SHOWER MISSION. AHTN NORMALLY PROVIDES TRANSPORTATION OF HOMELESS GUESTS TO A MEETINGHOUSE FOR LUNCH, SHOWER, HAIRCUT, SHAVE AND CLOTHING, ONCE A MONTH. WHEN THE PANDEMIC HIT THE MEETINGHOUSE WAS SHUT DOWN. THE COUNTY MADE ARRANGEMENTS WITH THE FAIRLESS HILLS YMCA TO OPEN UP THEIR DOORS TWICE A WEEK IN THE AFTERNOON FOR SHOWERS. AN AHTN PROVIDED TRANSPORTATION TO THE SHOWERS. THEN THE YMCA SHUT DOWN DUE TO RENOVATIONS, SO WE ARE CURRENTLY USING A MOTEL ROOM AT THE RODEWAY INN ONCE A WEEK SO THAT WE CAN PROVIDE OUR HOMELESS FRIENDS WITH DIGNITY.
