MOST OF OUR FAMILIES WERE HEADED BY A SINGLE PARENT OR A GRANDPARENT RAISING A GRANDCHILD. CHILDREN STAY AT BLESSING HOUSE BECAUSE THEIR FAMILIES ARE DEALING WITH HOUSING ISSUES, EMPLOYMENT ISSUES, MENTAL OR PHYSICAL HEALTH ISSUES, DOMESTIC VIOLENCE, SUBSTANCE ABUSE, AND LEGAL ISSUES. WE WORK IN PARTNERSHIP WITH OTHER AGENCIES AND PROGRAMS TO PROVIDE SUPPORT TO FAMILIES WHO HAVE CHILDREN AT RISK OF ABUSE OR NEGLECT.
