A letter dated 9/7/2016 from Nehemiah Reinvestment fund to JCCDC indicated the \$100,000 pulse interest was being wrote off their loan portl portfolio. JCCDC made the adjustment in their records to reflect their actions.

JCCDC had to make a adjustment to Liability Accounts Riley & Co and Jerry Riley Personal Loans. Riley & Co and Jerry Riley Personal made interest free Loans to JCCDC. Repayment of those loans for what ever reason were paid back to Jerry Riley Personal which over time created a negative balance of - \$11,499 which would seem like a over payment. We deducted that amount from Riley & Co. loan amount of JCCDC also made adjustment for payment to consultant UPDC by Riley & Co. for JCCDC in the amount of \$6500

JCCDC made a mistake in setting up CHDO proceeds account, which is required by our funder. This is money made from the sale of housing and must go back into creating new housing. JCCDC created a asset account which should have been an expence account for CHDO Procees ds.

JCCDC created invoices for renters and the City of PB. The payments were made but invoices stayed on the books, adjustment made to remove items.

The City of Pine Bluff Give JCCDC forgivable loans. The loan is forgiven when sale is made to a qualified buyer at time of sale. JCCDC made adjustment to remove from our records loans made that was forgiven.
