In 2019, we also partnered with Hennepin County Sheriff's office to undertake major campaigns targeted to immigrant communities. It was our most successful year on record.

We partnered with additional volunteers and agencies, helping us reach even wider audiences with increased services.

AICS integrates refugee clients into the main stream society, focusing on the most needy members of the community. In 2019, we doubled down on full-time employment and hiring agency referrals. Similar to 2018, we added more classes for job interview preparation skills. Since 2015, we placed a record number of people into short-term and long-term employment opportunities, including new job readiness/success programs in the greater Twin Cities metro specially cities with expanding immigrant populations.
