A significant portion of our Organization's budget and efforts are earmarked for enhanced public space management and security, streetscape, cleaning, maintenance, landscape and various other improvements and enhancements. In addition, professional information and safety officers on patrol daily work in tandem with Hawaii County Police to address criminal behavior. Streetscape maintenance crews enhance existing County-provided services with sidewalk cleaning and trash pick-up. We have successfully accomplished our stated "mission" and "goals" for the year.
