The organization operates the Food Security Group program at sponsors' sites so that low-income families have enough food, learn about healthy lifestyles, form uplifting community, and have opportunity for spiritual expression. In 2019, the organization distributed 208,711 pounds of food to 237 families and seniors with low income at 103 meetings in the Greater Atlanta area and 46 seniors with low income at 24 meetings in Augusta, GA. The 510 family members included 198 children age 17-and- under (39%) and 116 seniors (23%).

Form 990, Part III, Line 4b:

The organization teaches other non-profits and churches to operate their own food security groups. In 2019 there were 37 independent organizations in 16 states with a total of 74 food security groups.
