The organization operates the Food Security Group program at sponsors sites so the low-income families have enough food, learn about healthy lifestyles, form uplifting community, and have opportunity for spiritual expression. In the six months ending June 30, 2020, the organization distributed 118,247 pounds of food to 346 families and seniors with low income at 71 meetings in the Greater Atlanta area and 60 seniors with low income at 12 meetings in Augusta, GA. The 849 family members included 249,30%, children age 17-and-under and 72,8%, seniors

The organization teaches other non-profits and churches to operate their own food security groups. During the six months ending June 30, 2020, there were 37 independent organizations in 16 states with a total of 74 food security programs.

Usually FSA networks with similar organizations operating food co-ops. However, due to the pandemic, restrictions on travel and necessity of social distancing, these activities were curtailed. FSA is dedicated to resuming this important component of our mission when public health allows.
