AT THE REQUEST OF THE CCS BOARD OF DIRECTORS, JER HR GROUP PERFORMED THE STUDY AND RECOMMENDED A COMPENSATION AMOUNT TO THE BOARD OF DIRECTORS. THE BOARD OF DIRECTORS USED THE STUDY, ALONG WITH AN ANALYSIS OF THE TAX RETURNS OF SIMILAR COMPANIES IN THE INDUSTRY, TO DETERMINE THE COMPENSATION OF CCS'S OFFICERS. THE TEMPORARY RECEIVER/CEO WAS APPOINTED BY THE SUPREME COURT OF THE STATE OF NEW YORK IN AN ORDER DATED FEBRUARY 3, 2020, WHICH INCLUDED HIS COMPENSATION.
