WOMEN LIVE IN A SAFE ENVIRONMENT WITH OTHER WOMEN WHO ARE RECOVERING, WHERE THEY REGULARLY ACCESS COUNSELING AND SUPPORT. OTS IS UNIQUE IN THAT IT IS STAFFED ENTIRELY BY WOMEN WHO HAVE HAD LIFE EXPERIENCES SIMILAR TO THE WOMEN SERVED AND WHO ACT AS TRUSTED PEERS AND ROLE MODELS FOR RECOVERY. MANY WOMEN IN OTS REMARK THAT THE PEER-LED AND DEEPLY SUPPORTIVE MODEL IS UNLIKE ANY RECOVERY PROGRAM THEY HAVE ENCOUNTERED. FOR MOST, IT IS LIFE-TRANSFORMING. IN 2017, OFF THE STREETS SERVED 93 WOMEN, EMPOWERING THEM WITH THE CONFIDENCE, LIFE SKILLS, AND SUPPORT NETWORK TO ACHIEVE SOBRIETY, END THEIR INVOLVEMENT IN SEXUAL EXPLOITATION, FIND LONG-TERM HOUSING, AND PURSUE HEALTHIER LIVES.
