The women receive mental health and addition recovery services to help them reintegrate into society and become self-sufficient.

CUB continues to offer quality education through one remaining preschool, which in 2020 was incorporated into a new CUB program, Cincinnati Scholar House. This program prepares 3 to 5 year-old children physically, socially, and academically for successful entry into kindergarten. In addition, the program delivers supportive services to their families. The child development center allows children from families living in poverty the opportunity to reach critical developmental milestones, receive healthy meals every day, and learn from a research-based, child-centered curriculum . Our preschool is 5-star "step up to quality" rated by the Ohio Department of Job and Family Service, the highest rating possible. In addition to excellent education, we care for students' health and nutrition and work closely with their families to encourage stable and supportive home environments and engage them in needed community resources.

Form 990, Part III, Line 4b:

Residence Services - Founded in 1909, The Anna Louise Inn provides safe and affordable housing for women who would otherwise be homeless due to lack of income, mental health issues, or substance abuse. During 2020, The Anna Louise Inn housed 85 women between the ages of 19 and 87. All were economically disadvantaged, with most living on incomes below the federal poverty level. CUB partners with other service providers to ensure that the resident's individual needs are met. The Anna Louise Inn features 85 furnished efficiency apartments with 24 hour internal and external security to provide safety, a gazebo, gardens, and landscaping that create a peaceful oasis in the city. CUB staff provide supportive services that help residents gain more stability. Anna Louise Inn programming incorporates activities that promote health/wellness, community engagement, sewing and quilting, healthy cooking classes and fitness groups that educate and motivate women's self-sufficiency. Ann Louise Inn is not just a set of apartments, but a comprehensive program designed to serve the complex needs of Cincinnati's most vulnerable women. Funding for the programming comes from the City of Cincinnati and Foundation grants and is supported through building operations.

June 1, 2020 CUB added the Cincinnati Scholar House to its programs. The Scholar House is 44 units of 2 and 3 bedroom housing, specifically for single parents who are attending college, in pursuit of a degree. Scholar House housing is affordable and the program offers a variety of lifestyle trainings to support the parents. Trainings include cooking classes, financial literacy workshops, and parenting classes. Additionally, Scholar House has a 5-Star Step-up to Quality childcare center onsite, for both residents' children and children from the community (see program service 1).
