Other Program Services - In addition, Catholic Charities offers caregiver assistance to those caring for vulnerable loved ones, having supported 177 caregivers in 2019. Through its Senior Companions and Foster Grandparents programs, senior volunteers gave 132,053 hours of service to other seniors in need and to school children. Catholic Charities supported family development by providing Early Childhood Mental Health consultations to 1,086 children and Parenting Education classes to 82 parents. The agency conducted over 2,600 Mental Health Counseling sessions, and it supported 124 clients with Post-Adoption services. Over 10,000 hours of translation services were also offered to clients in multiple languages throughout the region through Catholic Charities' AccuracyNow Language Services.

Through Catholic Charities' Immigration Legal Services, 352 case services were provided to family members of U.S. citizens and permanent residents, those facing deportation, Deferred Action for Childhood Arrivals (DACA) applicants, victims of human trafficking, refugees, asylum seekers and anyone seeking naturalization.
