Explanation for Amended 990-T

For the tax year ending December 31, 2018, YMCA of Greater Dayton filed a 990-T return to report income of \$22,052 based on a calculation for the disallowed parking fringe benefit. The income from the parking fringe benefit resulted in \$4,421 of tax due.

On December 20, 2019, The Taxpayer Certainty and Disaster Relief Act of 2019 repealed IRC Section 512(a)(7) retroactively. Therefore, an amended return is being filed due to the repeal of Section 512(a)(7).

After amending Form 990-T, page 2, line 34 "Amounts paid for disallowed fringes" is now zero, and page 2, Part III is no longer computing any tax due. We are requesting a full refund of the \$4,421 that was paid with the originally filed 990-T.
