To provide financial stability and allow clients to remain in their own homes by providing nutritious meals to those who cannot prepare meals for themselves. Volunteers package and deliver the meals and provide daily contact with clients who are homebound.

In 2018, Mobile Meals of Marion County, packaged and delivered 7,135 meals to an average of 45 clients per month.
In 2018, we served a total of 139 clients using 95 volunteers and 4 paid staff. Our clients, who are unable to shop or prepare meals for themselves, include the elderly, disabled, sick, shut ins, those recuperating from hospitalization, and handicapped individuals. Our nutritious meals are designed and prepared by the staff of Marion General Hospital and recognize special diets including diabetic, low salt and renal.
Clients receive 1 meal per day, up to 7 days per week with weekend meals being delivered on Friday. Our services allow clients to remain in their homes and financially independent while receiving daily contact with individuals from their own community.
This is especially important to those who have no family in the area or live in rural areas.
