We provide access to investment capital combined with training and technical assistance to increase their capacity and likelihood of success. At fiscal year end, the combined portfolio of MACED and its affiliated nonprofit Appalachian Investment Corporation included 203 loans totaling \$19,411,181. In fiscal year 2019 we closed 55 loans, disbursing a total of \$2,877,229, of which \$1,952,561 went to startups. We helped create or retain 111 jobs, and our staff and contractors provided 4,824 hours of technical assistance.
