Inpatient Care - Monroe Medical Foundation, Inc operates a 49 bed acute care hospital The hospital admitted 1,551 patients treated 7,455 patients in the emergency room, treated 23,243 patients as outpatient referrals and made 2,140 ambulance runs in FYE 2-29-16 The patients admitted to the hospital as regular inpatients consisted of approximately 66% Medicare patients and 22% Medicaid patients Approximately 1% of patients admitted did not have Medicare or Medicaid, and did not have any type of insurance The hospital also began providing Swing Bed services in December 2014 We admitted 112 patients to the swing bed status during the fiscal year, and we had 1,036 swing bed patient days (Grants included 5 high school graduates' scholarships, 3 individuals receiving tuition assistance for nursing school and 1 physician receiving assistance with his medical school loans and 1 individual in Medical School)
