Programs include parenting education and coaching, individual, family and group counseling for children impacted by abuse and for adults who experience abuse as children and therapeutic visitation for families involved in the child welfare system. More than 3,500 children and adults participated in these direct services, and nearly 30,000 hours of direct service were delivered. More than 200 outside professionals participated in more than 2,000 hours of training and professional development. Due to COVID-19, we adapted and provided training virtually in the last quarter of FY20. This allowed people from across the country to access this quality training more easily, and expanded our reach and impact.
