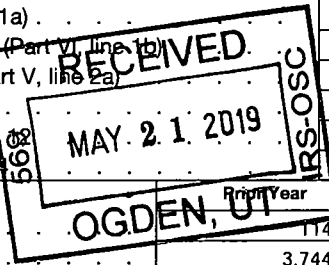

CHOICES, Inc. provided independent living services for a daily average of 40 youth between the ages of 17 and 21 in their own scattered-site apartments with the purpose of transitioning them into society (total of 14,455 bed days)

During FY18, CHOICES, Inc. also began providing independent living services to youth who previously emancipated from care. This program, funded by the State of Ohio and known as "Bridges", serves qualifying youth from enrollment until age 21. Two youth were served during the year under this program.

In exchange, ODJFS reimbursed CHOICES, Inc. \$15 per hour of training provided. During fiscal year 2012, CHOICES, Inc. partnered with the Institute of Human Services to hire a training liaison for the Ohio Child Welfare Training Program (OCWTP). OCWTP provides training to child welfare caregivers throughout Ohio. During fiscal year 2013, CHOICES, Inc. partnered with Clark County to hire an independent contractor from the Wendy's Wonderful Kid Program (WWKP). WWKP seeks to recruit adoptive homes for older foster youth. This WWKP arrangement ended 6/30/16. During fiscal year 2014, CHOICES, Inc. partnered with the Center for Adoption Support and Education (CASE) to provide training to child welfare caregivers specifically related to fostering and adoption. This arrangement ended in fiscal year 2017.
