SOAR OHIO - LAUNCHED IN 2008, COHHIO'S SOAR OHIO PROJECT HELPS EXPEDITE THE SSI AND SSDI (SOCIAL SECURITY DISABILITY INCOME) APPLICATION PROCESS AND REDUCE BARRIERS FOR DISABLED INDIVIDUALS (THOSE WITH A PHYSICAL DISABILITY AND/OR SERIOUS AND PERSISTENT MENTAL ILLNESS) WHO ARE EXPERIENCING HOMELESSNESS, ARE AT RISK OF BECOMING HOMELESS OR ARE PREPARING TO EXIT AN INSTITUTION DURING THE YEAR 1,156 INDIVIDUALS WERE COLLECTIVELY AWARDED \$3.5 MILLION IN DISABILITY BENEFITS THIS REPRESENTED \$2.2 MILLION IN YEARLY ALLOTMENTS FOR 313 PERSONS, \$1.3 MILLION IN YEARLY ALLOTMENTS FOR 122 PERSONS, AND MORE THAN \$3.1 MILLION IN BACK AWARD PAYMENTS FOR 306 PERSONS SINCE JULY 2008, THIS PROGRAM HAS ASSISTED 8,141 OHIOANS GAIN THE BENEFITS THEY WERE ELIGIBLE FOR, HELPING TO STABILIZE THEIR LIVES, AND THE LIVES OF THEIR FAMILIES THROUGH THE AWARD OF \$25 MILLION IN ANNUAL INCOME TENANT HOUSING INFORMATION/FAIR HOUSING - STABILIZING AT-RISK RENTAL HOUSEHOLDS, EXPANDING HOUSING CHOICE, PRESERVING AFFORDABLE HOUSING, EMPOWERING TENANT COMMUNITIES, AND ADVOCATING FOR TENANT'S RIGHTS ARE THE CORE ACTIVITIES OF THIS PROGRAM. STAFF MEMBERS PROVIDE DIRECT ASSISTANCE TO TENANTS, AS WELL AS, TRAINING AND TECHNICAL ASSISTANCE TO HOUSING SERVICE PROVIDERS AROUND THE STATE. COHHIO'S AFFORDABLE AND FAIR HOUSING COORDINATOR, SERVES AS AN AUTHORITATIVE RESOURCE ON HOUSING LAW FOR VARIOUS STATE AGENCIES, INCLUDING THE DEPARTMENT OF DEVELOPMENTAL DISABILITIES, OHIO MENTAL HEALTH AND ADDICTION SERVICES, OHIO HOUSING FINANCE AGENCY, OHIO DEVELOPMENT SERVICES AGENCY, AND THE OHIO ATTORNEY GENERAL. THE HOUSING INFORMATION LINE OFFERS FREE LEGAL ADVICE TO ANYONE WHO HAS A QUESTION RELATED TO HOUSING AND LANDLORD/TENANT ISSUES WITH A LAWYER ON STAFF, SUPPLEMENTED BY OSU LAW STUDENTS, COHHIO PROVIDES IN-DEPTH INFORMATION TO CALLERS. THE INFORMATION LINE COVERS A VARIETY OF HOUSING-RELATED TOPICS, INCLUDING LANDLORDS AND TENANTS' RIGHTS AND RESPONSIBILITIES, LEASE QUESTIONS, FORECLOSURE ISSUES FOR HOMEOWNERS AND TENANTS, PROPER EVICTION PROCEDURES, PROPERTY SALES, AND FEDERAL REGULATIONS. THE INFORMATION LINE HELPS KEEP FAMILIES AND INDIVIDUALS IN THEIR HOMES BY PROVIDING ADVICE TO BOTH TENANTS AND LANDLORDS TO PREVENT MISTAKES THAT LEAD TO UNNECESSARY AND/OR ILLEGAL EVICTIONS. DURING THE COURSE OF 2017, THE TENANTS/FAIR HOUSING PROGRAM HAD MORE THAN 4,000 CONTACTS WITH TENANTS, LANDLORDS AND OTHER SERVICE PROVIDERS IN THE HOUSING ARENA THROUGH TRAINING SESSIONS, PHONE CALLS, EMAILS, AND INFORMATION MAILINGS. THIS INCLUDED AN ESTIMATED 1,900 CALLS RECEIVED THROUGH THE HOUSING INFORMATION LINE, AND CONTACT WITH PARTICIPANTS IN 20 TRAINING SESSIONS COVERING LANDLORD-TENANT ISSUES AND FAIR-HOUSING LAW YOUTH HOUSING INITIATIVE - THIS PROGRAM, WHICH ADVOCATES FOR HOMELESS YOUTH, INCLUDING ABUSED AND NEGLECTED YOUTH, PARTNERS WITH ORGANIZATIONS THROUGHOUT OHIO. DURING THE YEAR, STAFF PROVIDED TRAINING AND TECHNICAL ASSISTANCE DETAILING BEST PRACTICES IN SERVICE DELIVERY AND IN MEETING THE BASIC NEEDS UNIQUE TO YOUTH EXPERIENCING HOMELESSNESS. PROGRAM STAFF CONVENED TWO REGIONAL COLLABORATIVES WITH A GOAL OF DEVELOPING A PLAN TO ENGAGE AND SERVE HOMELESS YOUTH USING A COORDINATED COMMUNITY APPROACH. THREE STATEWIDE WEBINARS FOCUSED ON BEST PRACTICES IN ADDRESSING YOUTH HOMELESSNESS, ELEVEN TRAININGS ON YOUTH WITH HISTORIES OF TRAUMA AND VICTIMIZATION, INCLUDING A TRAINING ON MERGING TRAUMA INFORMED CARE PRACTICES INTO SERVICE DELIVERY. IN ADDITION, SEVERAL TRAININGS TARGETED IMPROVING THE ACCURACY OF YOUTH COUNTS WITHIN THE ANNUAL POINT IN TIME COUNT. OVER THREE HUNDRED HOUSING PROVIDERS AND STAKEHOLDERS ACROSS THE STATE PARTICIPATED IN THESE TRAININGS. A NETWORK OF RUNAWAY AND HOMELESS YOUTH PROVIDERS WAS CONVENED QUARTERLY TO DISCUSS, PLAN AND COORDINATE ADVOCACY EFFORTS TO MEET THE NEEDS OF THIS VULNERABLE POPULATION. STAFF CONTINUED TO COLLABORATE WITH STATE AND LOCAL AGENCIES TO ADDRESS GAPS IN SERVICES AND SUPPORTS FOR HOMELESS YOUTH IN ORDER TO FACILITATE AND BUTTRESS A CROSS-SYSTEMS APPROACH TO YOUTH HOUSING. IN A NATIONAL COMPETITION, THE OHIO DEVELOPMENT SERVICES AGENCY AND COHHIO WERE ONE OF TEN PROJECTS AWARDED A \$2.3 MILLION HUD GRANT FOR A YOUTH HOMELESSNESS DEMONSTRATION PROJECT (YHDP). THE YHDP FUNDS ARE BEING USED TO SUPPORT THE DEVELOPMENT AND IMPLEMENTATION OF A COORDINATED COMMUNITY PLAN THAT ADDRESSES THE HOUSING AND SUPPORT NEEDS FOR YOUTH EXPERIENCING HOMELESSNESS IN A RURAL REGION OF OHIO.
