

We extended our partnerships and collaborations with other home care agencies throughout southwestern Ohio, even in a time of changing patterns in health care reimbursement by state and other government agencies. HCAT and STNA - The Home Care Aide Training program enrolled 42 individuals and graduated 35 trained aides over the year and assisted them in attaining and retaining their employment with many agencies and institutions in our area. We further supported their job success by providing a workforce job coach, who serves as a resource for our graduates as they enter the workforce, some of them employed for the very first time. The State Tested Nurse Aide program enrolled 38 individuals and graduated 30 trained aides. We also assisted them in retaining their employment and further supported their job success by providing a workforce job coach, who serves as a resource for our graduates as they enter the workforce.

Adult Education - Our dedicated education team of teachers and tutors helped 59 adult learners steadily increase their academic skills, provided workplace skills assessment and career coaching to 256 job seekers, and graduated 29 adults from the Hospital Worker Readiness Program.

Senior and Supportive Services - MNM serves on average 150 households per month for Senior and Supportive Services. This included a monthly Wellness Day, social activities, advocacy, accompaniment to doctor visits and social and spiritual visits for those who are home bound or in a facility. A total of 373 individuals received Supportive Services which includes food, financial assistance for State ID's, birth certificates and sometimes rent and utilities. An additional 231 individuals received referrals to other community resources. A total of 953 individuals received assistance to complete the Ohio Benefit Bank Quick check to determine eligibility for public support. We serve 26 individuals each month with Representative Payee Services.
