Inpatient treatment & housing - Joseph House provides the only comprehensive 12 month treatment program in the nation devoted to veterans. Over the past year, Joseph House has focused on the rate of recidivism among the veterans. A 20% reduction in recidivism and relapse has occurred over the last year. Joseph House served over 90 veterans during the 15-16 fiscal year

Outpatient and reintegration program - This is a 6-8 month clinical support program directed at the residents who have completed the in-patient program and need to begin the process of independent living. The clinical counselors use the Matrix Model of Outpatient Treatment. Over the past year, 37 residents have moved out of the Joseph House to a successful, permanent housing, living environment. Sixty-one residents have improved their income through employment or increased benefits
