Buckeye Ridge Habitat for Humanity tax returns are subject to examination by tax authorities, generally for three years after the filing date. Buckeye Ridge Habitat for Humanity records interest and penalties, if any, in interest expense and other expense, respectively, in operating expenses. During the years ended June 30, 2017 and 2016, no interest or penalties related to taxes were incurred. Buckeye Ridge Habitat for Humanity's ReStore sells merchandise that has been donated or purchased and the proceeds go directly to further the mission of Buckeye Ridge Habitat for Humanity. This activity may cause Buckeye Ridge Habitat for Humanity to be subject to Unrelated Business Income Tax (UBIT). The IRS specifically excludes from UBIT under IRC513(a)(3), the selling of merchandise if substantially all of the resale items have been received via gift or donation. While the IRS has not defined what substantially all means, the Habitat for Humanity International Affiliate Operations Manual specifies that 87.5% of UBIT needs to have come from donated items to be excluded from UBIT. For the years ended June 30, 2017 and 2016, Buckeye Ridge Habitat for Humanity's unrelated business income meets the 87.5% criteria and is excluded from UBIT. Accordingly, no provision for income taxes has been recorded.</p>
