**Statement of Program Service Accomplishments (Part III):** During 2019, Cincinnati Works acquired Beacon of Hope Business Alliance (tax ID #47-4326461). The Beacon of Hope Business Alliance mission is to address, educate, coordinate, and provide resources to assist second chance hiring at local, national, and global levels. They do so by providing connections and resources to assist individuals who have barriers to employment. One of the services provided to address barriers to employment is transportation. Cincinnati Works continued this initiative after the acquisition date of August 1, 2019.

**Statement of Program Service Accomplishments (Part III Other Program Services):** The organization provided transportation services to assist members reach their employment site location, thus removing an underlying employment barrier.
