Through the use of publicly donated and developed funds provided financial assistance to 974 households (1,504 individuals) qualified low-income households in the State of Georgia for the payment of household energy costs. Funding was made to the Georgia Department of Human Services (DHS) to be used and administered in concert with their LIHEAP program and under their guidelines for benefit qualification. Similarly, through the use of a grant by the Georgia Public Service Commission provided financial assistance to 2,240 households (3,227 individuals) within the service area of the Atlanta Gas Light natural gas pipeline to prevent disconnection or restore energy service based on funding guidelines.
