 The JetPack Project is a backpack food program providing nutritious, non-perishable food to children in need of food assistance over the weekends and during school breaks. The Well served on average 440 students in fy16-17. These 440 students received food assistance every weekend during the school year and during scheduled holiday breaks over the school year. The Well services 14 local elementary, middle and high schools located in Williamson and Maury Counties.

 The Well Outreach operates a food pantry on Tuesday, Wednesday, Thursday and Saturday mornings from 10:00 a.m. - 12:00 p.m. and Tuesday and Thursday evenings from 6:30 p.m. - 8:00 p.m. Eligible households may visit the pantry for assistance twice per month and as often as needed for bread. Families may also receive USDA food once per month.  
 The Well served 100 households per month on average or 319 individuals per month. The Well distributed a total of 187,867 pounds of food in fy 16-17.  
 The Well relies on volunteers and food donations to serve our community. The Well received 241,879 pounds of donated food in fy16-17. Volunteer hours for fy 16-17 was 4,718 which averages to approximately 90 hours per week.
