The Well Outreach exists to be the hands and feet of Jesus by serving those in need through supporting spiritual, emotional and physical growth. For over a decade, The Well has provided food assistance in Spring Hill, Thompson's Station, College Grove and North Columbia, TN.

The JetPack Project is a backpack food program providing nutritious, non-perishable food to children in need of food assistance over the weekends and during school breaks. The Well served on average 387 students in fy 17-18. These 387 students received food assistance every weekend during the school year and during scheduled holiday breaks over the school year. The Well services 14 local elementary, middle and high schools located in Williamson and Maury Counties.
The Well is able to provide this program through grants and donations from local churches. The Well received \$10,000 in local grants and \$30,938 from local churches in fy 17-18 to fund the JetPack Program.

4b (Code:) (Expenses \$ 21,144 including grants of \$) (Revenue \$)
The Well Outreach operates a food pantry on Tuesday, Wednesday, Thursday and Saturday mornings from 10:00 a.m. to 12:00 p.m. and Tuesday and Thursday evenings from 6.30 to 8-00 p.m. The Well offers extended hours on Tuesdays to serve clients until 1:30 p.m. Households may visit the pantry for assistance twice per month and eligible families may also receive USDA food once per month.
The Well served 110 households per month on average or 366 individuals per month. The Well distributed a total of 131,826 pounds of food in fy 17-18.
The Well relies on volunteers and food donations to serve our community. The Well received 208,574 pounds of donated food in fy17-18. Volunteer hours for fy17-18 was 6,369 which averages to approximately 122 hours per week.

The Well was provided the opportunity to host five Mobile Food Pantries (MFP) through Second Harvest of Middle Tennessee.
August 2017, 120 households were served through a MFP,
October 2017, 130 households were served through a MFP,
November 2017, 184 households were served through a MFP,
April 2018, 118 households were served through a MFP,
June 2018, 132 households were served through a MFP.
The Well in partnership with Second Harvest Food Bank of Middle Tennessee was able to provide food assistance to 684 households in fy 17-18 through the Mobile Food Pantry Program
The Well is able to provide the Mobile Food Pantry through grants provided by Second Harvest of Middle Tennessee.
