The Texas Ramp Project provides free wheelchair ramps to elderly and disabled clients in financial need identified by local health care providers. Ramps are built exclusively with volunteer labor, keeping costs to a minimum. Ramps are built without regard to race, religion, ethnicity, age or gender. Our vision is that no Texas resident shall lack safe access to and from his or her home because of financial limitations

During 2017 the Texas Ramp Project constructed 1,955 ramps which were provided at no charge. The average ramp length was 28 feet and the average ramp cost was only \$580, which is two to three times less than a commercially supplied ramp.

The reported 2017 financial shortfall was due to large revenues in 2016 that were applicable to 2017 construction activity.
