The Early Childhood Resource Center is dedicated to improving the quality of childcare in Stark and surrounding counties. This is accomplished by providing training and networking opportunities as well as an extensive resource library to its members. The members consist of families with young children, child care staff, and community agencies serving families with young children. In 2017 ECRC provided 1,233 hours of professional development training and 12,000 members participated in ECRC's workshops. Child Development Associate (CDA) classes were provided to childcare workers who working to attain CDA credentials and 180 childcare workers completed the CDA classes. ECRC maintains a production lab that is available to all members for a nominal annual fee. Members can use the lab to provide educational, age appropriate materials and activities for preschool children. In 2017, there was 2,257 visits to the production lab. ECRC also provides accreditation and support services for home day care providers who wish to enroll in the Step Up to Quality rating system. In 2017 ECRC offered over 150 family programs that focused on literacy, math, music, social studies, and science.

The Supporting Partnerships to Assure Ready Kids (SPARK) program is a home-visitation model that focuses on kindergarten readiness. ECRC works with children, families, schools, and the community to ensure that their children succeed in school. SPARK engages participating families in structured lesson plans and activities aligned with Ohio's Early Learning and Development Standard, administers developmental assessments and screenings, and initiates referrals to needed community resources. SPARK and schools work collaboratively to ensure that children experience smooth transitions into school. In 2017 over 4,400 children participated in the SPARK program.

The ECRC service as a Child Care Resource and Referral (CCR&R) agency for six counties in Northeast Ohio. As a CCR&R agency, ECRC serves as a regional hub for Mahoning, Medina, Stark, Portage, Summit and Warren counties. In addition, ECRC provides support to providers, parents and the community, working with 875 child care providers.
