OUR EARLY CHILDHOOD LEARNING CENTER MARKED A SIXTH YEAR OF BEING DESIGNATED A STEP UP TO QUALITY FIVE-STAR RATED CENTER. OUR CENTER PROVIDES QUALITY CARE AND EDUCATION SERVICES TO CHILDREN FROM AGES SIX WEEKS TO ELEVEN YEARS. IN 2019, 122 CHILDREN AND 93 FAMILIES BENEFITTED FROM OUR PROGRAMMING. ECLC ACTIVELY PARTICIPATES IN THE EARLY HEAD START PARTNERSHIP AND CANTON CITY PRESCHOOL EXPANSION. NEW BEGINNINGS HOUSING PROVIDES PERMANENT SUPPORTIVE HOUSING FOR SINGLES AND FAMILIES. PERMANENT SUPPORTIVE UNITS PROVIDE LONG-TERM LOW-INCOME HOUSING PLUS SUPPORTIVE SERVICES TO MAINTAIN STABILITY WITHIN THE HOUSEHOLD. IN 2019, 34 HOUSEHOLDS CALLED NEW BEGINNINGS HOME SERVING 44 ADULTS AND 9 CHILDREN. GATEWAY I AND II PROVIDE HOUSING FOR THE HARD-TO-HOUSE HOMELESS. THE GOAL OF THE HOUSING IS TO ASSIST HOMELESS INDIVIDUALS IN MAINTAINING PERMANENT HOUSING AND FINANCIAL STABILITY IN AN INDEPENDENT LIVING ARRANGEMENT. IN 2019, 47 INDIVIDUALS WERE HOUSED AT OUR GATEWAY I BUILDING AND 67 INDIVIDUALS AT GATEWAY II.
