LEGAL AID ADVOCATES WORK WITH COUPLES WHO HAVE DECIDED THAT WHAT'S BEST FOR THEM IS A CLEAN BREAK AND A FRESH START, AND WITH VICTIMS OF DOMESTIC ABUSE WHO NEED TO PERMANENTLY SEPARATE FROM THEIR ABUSER. BY HELPING RESOLVE THESE INTERPERSONAL CONFLICTS WITH LEGAL SOLUTIONS, LEGAL AID RELEASES THE STRESS THEY FEEL IN THEIR HOME LIFE AND ALLOWS THEM TO REGAIN CONTROL OF THEIR LIVES AND FOCUS ON BEING HEALTHY, PRODUCTIVE, AND MEANINGFUL MEMBERS OF THEIR COMMUNITY.
