Family and Childrens Services These programs include the Federal Head Start programs accounting for approximately 70 of the Agencys total fiscal 2020 revenue, and the Federal Child and Adult Care Food Program which provides children participating in the Agencys various Head Start Programs with meals and snacks throughout the day. The Federal Head Start and Early Head Start programs served 891 and 40 children, respectively during the Agencys fiscal year ended July 31, 2020.

Home Energy Assistance Programs The Home Energy Assistance program is funded by Federal grant revenues and provides assistance with heating and air conditioning of residential properties for low-income individuals who meet certain other eligibility requirements. The program makes monthly payments in 2020 to offset and help households with heating and cooling crises.
