Subsequent Event

On January 1, 2018 Waycraft, Inc. privatized. It will no longer receive Crawford County's subsidy of approximately \$204,000 as in past years. It also will not be a component unit of Crawford County. The reason Waycraft, Inc. privatized is the adult sheltered workshop industry is changing nationally due to litigation, legislation, and competition in the private sector. There is more emphasis to have adults with developmental disabilities to work in the community than in sheltered workshops. Waycraft, Inc. will be billing the Medicaid System instead.

IRS990-T

Waycraft had unrelated rent income for years and filed a IRS990-T. In 2017 the tenant was evicted due to nonpayment of rent. The attached IRS990-T will be the last return filed and in the future, Waycraft, Inc. will show no rent income on its financial statements. Due to the subsequent event noted above, Waycraft, Inc. had to move its administrative offices from the Crawford County Board of Developmental Disabilities building to the Workshop building and took over the space of the former tenant.
