Akron Development Corporation was organized to support economic development initiatives in the City of Akron, particularly through the Akron Global Business Accelerator, and, to secure State of Ohio funding for technology-based businesses.

Akron Global Business Accelerator provides a package of business and technical services that lead to the commercialization of new technologies, the formation of new companies, and, the creation of jobs.

Their international business attraction program focuses on attracting early stage, technology-based international business through targeted marketing initiatives. Business opportunities are screened to determine the best fit for the City of Akron. They provide coordinated support for companies entering the U. S. Market through the Akron Global Business Accelerator (see 4a above) including funding and leveraging appropriate resources.

4c (Code: ) (Expenses \$ 199384 including grants of \$ ) (Revenue \$ 0)

Their entrepreneurial signature program focuses on assisting fledgling entrepreneurs in converting ideas into successful technology-based businesses. Through the Akron Global Business Accelerator (see 4a above), entrepreneurs are advised and assisted on all aspects of business development and connected to resources in all areas of expertise necessary to establish business operations and commercialize technologies.

Their biomaterials commercialization hub (Hub) program's focus is on three primary areas of activity: 1) collaboration aimed at developing innovative technologies and prototypes in the areas of biomaterials for orthopedics and wound healing applications; 2) establishing and attracting new companies in the areas of biomaterials for orthopedics and wound healing applications; and, 3) supporting urban development of the Hub area and foster job creation. The Executive Director of the Hub is responsible for day to day management and planning.
