**The Akron Development Corporation was organized to support economic development initiatives in the City of Akron, particularly through the former Akron Global Business Accelerator and to secure State of Ohio funding for technology-based businesses. (The former Akron Global Business Accelerator spun off from the city of Akron and is now an independent entity known as the Bounce Innovation Hub, which commenced operations on January 1, 2018.)**

**The Bounce Innovation Hub (formerly known as the Akron Global Business Accelerator), an independent entity that spun off from the Akron Development Corporation and commenced operations on January 1, 2018, is the region's first open innovation hub serving Northeast Ohio's entrepreneurial and innovation community. The building comprises more than 300,000 square feet of co-working, event and meeting space and office, lab and light manufacturing space. With more than 50 organizations in the building, Bounce accounts for more than 250 people working and creating. Bounce currently offers a technology company incubator program, a software accelerator, and the physical product iterator program in partnership with MAGNET. Bounce's first floor, the Generator, is open to the public and comprises 27,000 square feet, and includes co-working space and private offices; event and meeting space; The Workshop: A Creative Co-op; The Remarkable Coffee and Cafe; and a 24-seat, state-of-the-art, e-sports facility. Through in-house programs and community partnerships, Bounce currently serves more than 55 startups in Northeast Ohio.**

**Fiscal year operating performance included revenues of \$34,134,791; investments of \$13,794,672; 46.50 jobs created (244 total jobs); two patents granted (33 total grants); and female/minority owned business ownership of 29%.**

**The City of Akron utilized the Akron Development Corporation to maintain the recordkeeping of its Economic Development Strategic Plans initiative, which involved the use of two well-respected entrepreneurial and technological consultants. Among other activities required by the City of Akron's administration, the consultants played a huge role in the creation, development and success of the Bounce Innovation Hub.**

**The Highland Square Economic Development, LLC ("HSED, LLC") is an entity within the Akron Development Corporation that assisted with the creation of a local health food market, known as The Mustard Seed, to expand into a developing neighborhood.**

**During 2018, the cash flow of the company was sufficient to service its debt. Furthermore, operating expenses were largely comprised of (non-cash) depreciation expenses of \$375,347.**
