IN ADDITION, SIL HOSTED TWO FORUMS ON TRANSPORTATION EQUITY (ONE REGIONAL AND ONE STATEWIDE). SIL TRAINED 1,964 PROFESSIONALS AND OTHER COMMUNITY MEMBERS ON ADDRESSING BARRIERS TO COMMUNITY LIVING. SIL ALSO MAINTAINS AN ACTIVE FACEBOOK SITE AND CONTINUES TO INCREASE ITS PRESENCE ON TWITTER. YOUTHABILITIES: A YOUTH TRANSITION PROGRAM PROVIDING SUPPORT TO YOUTHS WITH DISABILITIES. THE PROGRAM SERVED 87 YOUTHS AND FOCUSED ON SKILL BUILDING, SELF-ADVOCACY AND OTHER INDEPENDENT LIVING SKILLS. THIS IS AN AREA SIL HAS IDENTIFIED AS A PRIORITY. ACTIVITIES INCLUDE PARTICIPATION ON LOCAL, STATE AND NATIONAL COALITIONS, COMMITTEES AND TASK FORCES. IN ADDITION, SIL HOSTS ACTIVE TRANSPORTATION EQUITY COALITIONS ON BOTH THE STATE AND LOCAL LEVEL TO ADDRESS TRANSPORTATION BARRIERS.
