The Child and Adult Care Food program provides support for childrens meals for children attending licensed child care centers, including Head Start, Early Head Start and child care classrooms. Portage Learning Centers ensures that children participating in all classrooms have access to nutritious meals, including a variety of foods served that introduce children to new food options and offer balanced meals. Meals are served family style to encourage childrens healthy development. Children in full day classrooms receive breakfast, lunch and snack. Children served in half-day preschool classrooms receive either breakfast and lunch in morning classrooms or lunch and snack in afternoon classrooms. Additionally, Portage Learning Centers, provides information to parents about healthy eating and the importance of exercise and movement as part of both the Head Start and Early Head Start programs.
