Meals are served family style to encourage childrens healthy development. Children in full day classrooms receive breakfast, lunch and snack. Children served in half-day preschool classrooms receive either breakfast and lunch in morning classrooms or lunch and snack in afternoon classrooms. Additionally, Portage Learning Centers, provides information to parents about healthy eating and the importance of exercise and movement as part of both the Head Start and Early Head Start programs.

Wage comparability studies are performed every three years for all employment categories and they are documented. The results of these studies, along with performance, are the basis for salary adjustments.
