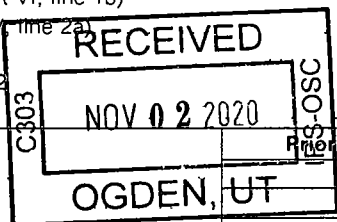

Guests can come only with a member, and is limited to three times, and then he/she must decide to be members. The member is responsible for the guest and the guest is not allowed to buy his/her own drinks.

Their veterans and community activities are the following: they visit the the VA hospital at Sandusky, OH, provide the veterans with transportation to the Veterans Hosp., provide color guards to various community events, provide U.S. flags to various public schools, provide honor guards to all veterans funerals in their county, provide food baskets to needy veterans, they participate in the local Vet.
