Homeownership In 2015, Maumee Valley Habitat for Humanity closed on 5 homes built or rehabbed to lower-income families of Lucas County through 0% interest loans. The homes are also affordable to families with limited income because of the 29,934 donated labor hours by 942 volunteers in 2015 and the support of generous donors and sponsoring organizations. Through the Homeownership Program 17 adults and children were housed in 2015. Each future homeowner partners with the affiliate prior to the purchase of their home through 250 hours of sweat equity hours in which they attend homeowner, financial, and home maintenance education classes and volunteer with the affiliate. Through our 2015 title (10% gift of all undesignated donations) to Habitat for Humanity Ethiopia, Haiti, and Tajikistan, an additional 4 families were housed in 2015 bringing the total to 105 international families since Maumee Valley Habitat's inception

ReStore Operations ReStore sells new and used building materials, appliances, and larger home furnishings at a great value to shoppers. Most items for sale are donated to ReStore which provides health and safety related repairs. A Brush with Kindness (ABWK) provides exterior painting and maintenance of homes to protect the home from water damage and to maintain the curb appeal and value of the home and neighborhood. Both programs are offered to homeowners at just the cost of materials. Homeowners are also offered a 0% interest loan if needed. In 2015, 38 families partnered with Maumee Valley Habitat through HRM and ABWK.

Repair Programs The affiliate offers lower-income homeowners in Lucas County two repair programs to help them maintain the safety and value of their home. Both programs are offered to homeowners at just the cost of materials. Homeowners are also offered a 0% interest loan if needed. In 2015, 38 families partnered with Maumee Valley Habitat through HRM and ABWK.
