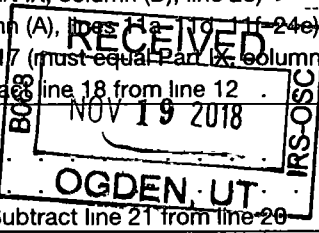

The mission of Court Community Service is to design and manage an efficient system of quality alternative sentencing options responsive to the needs of the courts and the community.

Placement & Referral for area Municipal, US District and County courts. Adults ordered to perform community service work as a condition of probation or in lieu of financial sanctions are interviewed and placed to work under supervision at not-for-profit and government agencies. The progress of each referral is tracked & status reports given to referring court. Received 7,908 community service referrals that worked 206,553 hours at 212 local non-profit agencies. Revenue and hours above includes some income and hours utilized in 4b below.

Work Crew Program consists of several supervised work crews comprised of community service workers. A paid supervisor transports the crew to & from designated worksites. Crews perform litter collection, community cleanups, landscaping & graffiti removal. They also assist area not-for-profit agencies with community projects. Some revenue for this function is reported in 4a above. Supervised work crews collected 71,756 bags of litter, 19,879 tires & 13,977 cubic yards of debris throughout Cuyahoga County.

Carrying Concealed Weapon (CCW) Program is a 3 hour educational program covering the legal consequences & personal dangers involved in the purchase, possession and use of firearms or other weapons. Area courts refer individuals convicted of CCW or similar charges. The program is aimed at reducing recidivism while providing an overview of current weapon related laws. Received 307 CCW program referrals.

Pt VI, Line 1a: There is an Executive Committee of the Board of Trustees.

The Committee is comprised of five members, all of whom  
are members of the Board and officers of the organization.

During intervals between Board meetings, the Committee is  
empowered to exercise all of the Board's authority other  
than the authority to appoint or elect Board members.

Pt VI, Line 11b: The organization's process for reviewing Form 990:

1. After the staff completes a draft of the Form 990,

it is sent to all members of the Form 990 Committee  
of the Board, and the Committee Chair leads a  
section-by-section discussion of the draft at a  
meeting of the Committee.

2. The Board reviews the draft Form 990 at its regular

meeting after completion in a section-by-section  
discussion led by the President or his/her designee.

3. The Executive Director signs and dates the Form 990,

including any changes recommended by the Committee  
or the Board, and sends copies to all Board members.

4. The Form 990 is then filed with the Internal Revenue

Service.

Pt VI, Line 12c: To monitor and enforce compliance with the organization's conflict

of interest policy, all Trustees, officers and any key employees

annually complete a questionnaire. The questionnaire responses

are reviewed to determine if any such individuals have actual or

potential conflicts of interest. If any actual or potential conflicts

are identified, they are brought to the attention of the Board for appropriate disposition.

Pt VI, Line 15a: The organization's process for determining the Executive Director's compensation is as follows:

1. The Executive Compensation Committee of the Board of Trustees meets at least once each year to set the Executive Director's compensation for the following calendar year. None of the Committee members has a conflict of interest with respect to the Executive Director's compensation arrangements. The Committee utilizes comparability data and keeps contemporaneous minutes of its deliberations and decisions.

2. The Committee reports its decisions to the Board at the regular December meeting of the Board.

In 2017, the only position for which this process was used was that of the Executive Director. This process has not been used for any other officers or key employees since no other officers are compensated, and the organization has no other key employees.
