THIS WAS THE FIRST MAJOR RENOVATION OF THE SHELTER SINCE THE INCEPTION OF THE PROGRAM 30 YEARS AGO. THE IMPACT OF THE PROJECT ON FAMILY PROMISE AND ITS CLIENTS IS SIGNIFICANT. AT THE CLOSE OF 2018, THE AGENCY HAD RAISED ALL DOLLARS NEEDED TO FULLY FUND THE RENOVATION PROJECT, INCLUDING REPAYMENT OF A LINE OF CREDIT TAKEN TO REIMBURSE CONTRACTORS DURING THE FUNDRAISING EFFORT. BY THE END OF 2018 ALL DEBT FOR THE PROJECT HAD BEEN RETIRED; AND DOLLARS HAD BEEN RAISED TO UNDERTAKE THE REMAINING PROJECTS, INCLUDING THE RENOVATION OF THE PARKING LOT, WHICH WAS COMPLETED IN 2019.</p>
