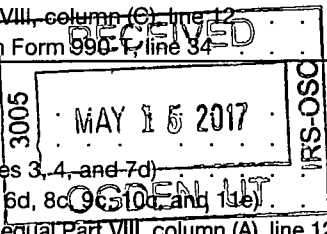

Hope House provides a homeless shelter for women and children. Families are provided food, shelter, counseling, and job search to help prepare for independent living. Approximately 60 women and children are assisted annually.

4b (Code:) (Expenses \$ 61500 including grants of \$) (Revenue \$ 60992)
Housing office provides free assistance to approximately 6900 low income individuals and families, landlords, or management companies to prevent eviction or foreclosure by providing mediation, conflict resolution, and community referrals. Hope House does not provide cash assistance to obtain and maintain safe, decent, affordable housing either by renting or purchasing housing.

4c (Code:) (Expenses \$ 453800 including grants of \$ 331669) (Revenue \$ 453800)
Independence Program provides RRP Rapid Rehousing. The program is a 3-6 month rental assistance program in which households have monthly co-pays while receiving assistance. Qualifications are the adult must be literally homeless, must have proof of income and be an adult resident of Hancock, aged 18 or above.
