The Board of Trustees also acts as the initial approval for Cuyahoga County's loan programs.

Financial Assistance - To advance, encourage and promote the industrial, economic, commercial, civic development and create or preserve industrial, commercial, distribution, and research and development. The Cuyahoga County Community Improvement carries out its exempt purpose by reviewing Industrial Revenue Bond applications on behalf of the County and/or its political subdivisions.

In the current year the Board reviewed "1" bond applications, in the amount of \$35 million.

In the current year in its role as the initial approval for Cuyahoga County's loan programs, the Board reviewed 4 loans representing \$27,833,319 in investment and 99 new jobs.
