ABAWD Work Experience Program (WEP) was funded through a grant agreement with Franklin County Department of Job and Family Services in the amount of \$378,100 supported these outcomes: Work readiness Assessments. Staff completed work readiness assessments with 682 Franklin County adults, identifying barriers to employment and placing participants into work experience slots at 32 community-based locations. Promoting Paid Employment. 76 participants found paid employment, earning an average of \$11.13 per hour, and exited the program. Home Energy Assistance Program (HEAP) Outreach received a grant in the amount of \$75,000 from the Ohio Development Services Agency to support a contract with Community Reinvestment Resources, LLC, an organization established that operates the Veterans Comprehensive Assistance Program (VCAP), through this program VCAP helped 379 veterans apply for HEAP benefits. VCAP also helped connect 235 veterans with SNAP benefits.

The Ohio Association of Foodbanks partners with the Corporation for National and Community Service to carry out national service programming including AmeriCorps VISTA and AmeriCorps VISTA Summer Associates. VISTA members perform a wide variety of activities depending on the program in which they participate. Some of these activities include supporting Summer Food Service Program summer sites. All VISTAS contribute to capacity building at the organizations in which they are placed. To date, the Ohio Association of Foodbanks has placed more than 1,257 national service members, those national service members have recruited 41,000 volunteers who have served more than 5.468 million summer meals and raised 4.5 million in cash and In-Kind donations.
