THE ORGANIZATION PROVIDES DIAGNOSIS, TREATMENT, AND PREVENTATIVE HEALTH SERVICES, MEDICAL, DENTAL, AND BEHAVIORAL HEALTH SERVICES TO A LARGELY MEDICALLY UNDERSERVED POPULATION. WE HAVE SERVICES AT PORTAGE PATH BEHAVIORAL HEALTH FOR INTEGRATED CARE AND WOMEN'S HEALTH AND INTERNAL MEDICINE FOR ADDITIONAL SERVICE LINES. OUR SERVICES INCLUDE PRIMARY CARE, PEDIATRIC CARE, SPECIALTY REFERRALS, CASE MANAGEMENT, DIABETIC EDUCATION AND ACCESS TO CARE. IN 2015, 17,562 PATIENTS WERE SERVED.
